Dear Phi Gamma Delta (FIJI):

This letter is to inform you, as president of the Phi Gamma Delta (FIJI) chapter at Louisiana State University, that the University has ordered an **Interim Suspension of Activities for all chapter events as a result of an incident reported on September 10, 2026. The chapter is now under investigation regarding potential violations of the LSU Code of Student Conduct. See the attached report for additional information.**

As a result, the following section(s) of the LSU Code of Student Conduct will be considered:

10.2 Complicity: Attempting to commit, knowingly permitting, encouraging, or assisting others with the commission or attempted commission of any act, omission or conduct prohibited under this Code.

10.2 Coercive Behavior: An act by an individual or a group that, as an explicit or implicit condition for initiation to, admission into, affiliation with, or continued membership in a group or organization, regardless of consent, which tends to or which is intended to demean, disgrace, humiliate or degrade a Student, which includes but not limited to forced conduct that could result in extreme embarrassment, or other forced activity that could adversely affect the mental health or dignity of a Student. Examples of coercive behavior include, but are not limited to, line-ups, scavenger hunts and personal servitude.

10.2 Hazing: Hazing means an act by an individual or a group that, as an explicit or implicit condition for initiation to, admission into, affiliation with, or continued membership in a group or organization, regardless of consent:

1. Endangers the physical health or safety of a person or would cause a reasonable person severe emotional distress;
2. Results in the destruction or removal of public or private property;
3. Involves the consumption of alcohol or drugs;
4. Involves the consumption of substances to excess or placement of substances on the body;
5. Involves sexual activity;
6. Involves violation of federal, state or local law or University policy; or
7. Disrupts the academic performance or class attendance of a person.

Please see Section 10.2, Hazing, in the LSU Code of Student Conduct for additional information.

Due to the potential threat the alleged behavior may pose to the LSU campus community, the organization is placed on interim suspension immediately under Section 7.2, Interim Measures, of the LSU Code of Student Conduct. The following Interim Measures are imposed effective immediately:

1. Contact between new members and initiated members is prohibited outside of approved ritual or chapter meetings at the fraternity house. This includes direct, virtual, or third-party contact, including but not limited to electronic correspondence, verbal communication, or contact through mutual acquaintances. Any verbal or non-verbal contact outside of the above-mentioned parameters could constitute a violation of the LSU Code of Student Conduct.
2. The chapter may not host or participate in any social activities, including exchanges, socials, or parties, on or off campus.
3. The chapter may not participate in any intramural activities.
4. The chapter may not conduct any meetings unless directed by the University to assist in the investigation.
5. The chapter may request permission to conduct ritual meetings with Alumni Advisory Board members present to facilitate new member education and carry out essential chapter business. The chapter president and advisor must notify Greek Life in writing at least 24 hours in advance to request permission to hold a chapter function.
6. New members participating in the chapter's meal plan may pick up meals to go until the investigation is complete.

At this time, our office will initiate the Interim Measures process outlined in the LSU Code of Student Conduct. You will receive another letter stating the date and time of the organization's Interim Measure Review Meeting, which will be held no later than seven (7) business days from today's date. This review will be conducted by the LSU Dean of Students designee and one other designee. The review may result in the continuation, revocation, and/or modification of the Interim Measures. You are allowed an advisor of your choice to participate in this review with you. Please acquaint yourself with the LSU Code of Student Conduct prior to your appointment.

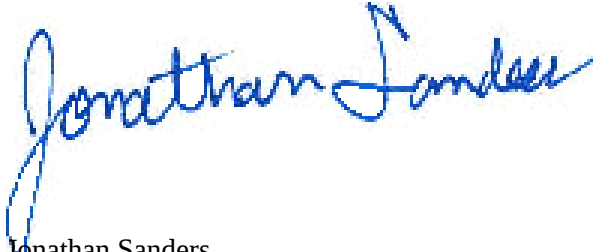
One or more of your organization's officers are welcome to attend the Interim Measure Review Meeting; however, you should select one officer to serve as the official representative for Phi Gamma Delta (FIJI). Typically, this is the Chapter president. You have the right to have an attorney or non-attorney advisor of your choice fully participate in the Accountability Process. Please reply to this letter with the name(s) and role(s) of the student leader(s) representing the RSO no later than 24 hours before the meeting time.

The Director of Greek Life, your advisor, and a representative from your Inter/National Organization have been copied on this email so they are aware of this information and that the Partnership Process has begun.

Please ensure that your members and new members understand and adhere to this directive and are aware of the implications for non-compliance. If any further incidents occur, you will continue to jeopardize the future of the chapter, and you, as the executive member, may be charged with Failure to Comply with a University Official.
